# Description

This 90-minutes <u>online forum event</u> will bring to the attention of IUCN's constituency and Congress participants the fundamental importance of primary forests and intact forest landscapes (PF&IFL) in maintaining biodiversity, storing carbon and providing the ecosystem goods and services on which human society depends.

The PF&IFL Task Team, created by WCC-2016-Res-045-EN, developed <u>IUCN's PF&IFL Policy Statement</u> which was adopted by IUCN's Council in February 2020. This policy statement lays out critical actions that need to be undertaken to stop fragmentation, damage and loss of these forests, and safeguard the terrestrial world's most important guardians of life – a responsibility we all share.

## **Outcome**

The outcome of this session is to bring attention to the special place that primary forests, including intact forest landscapes, needs to occupy in international policy and the minds of and actions from decision-makers and agents of change. By doing this the event will amplify the importance and prioritise the conservation of these precious forests.

#### **Format**

The event will be divided into three sections moderated by members of the PF&IFL Task Team. After an overview presentation of the Policy Statement, panellists will engage in a discussion on examples of efforts to protect PF&IFL and what are the immediate actions to be taken from the investment, collaboration and non-state actors sides to ensure that PF&IFL remain as such, for the benefit of our future. The audience and panellists will interact through live activities during each of the sections.
